RESOLUTION NO. 090566

WHEREAS, Section 17, Article XI of the 1987 Constitution requires public officers and employees to submit upon assumption of office and during such period as may be required by law, sworn statement of their assets, liabilities and net worth (SALN);

WHEREAS, the requirement on the filing of SALN is reiterated in Republic Act No. 3019 (Anti-Graft and Corrupt Practices Act) and Republic Act No. 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees);

WHEREAS, the Civil Service Commission, as the central personnel agency of the government, in its effort to properly effectuate the constitutional and statutory provisions on public disclosure and to establish a standard review and compliance procedure to be observed by all public officers and employees in the submission of their SALN, has come out with new forms for purposes of compliance with the requirement on the filing of SALN;

WHEREAS, the Commission has received numerous queries and/or requests for clarification and/or deferment on the use of said new forms in the submission of the SALN;

WHEREFORE, the Commission **RESOLVES** to allow public officers and employees to continue using the old 1994 Statement of Assets, Liabilities and Net Worth (SALN) for the year 2008, the deadline for filing of which is April 30, 2009.
